COVID-19 Response

Navigating unprecedented times

As we adjust to the reality of COVID-19 and its impact, Saint Mary's has been working diligently to protect the loved ones in our care and to communicate our active efforts for prevention and containment. Ensuring that we provide a safe and healthy environment for our residents and employees is our top priority.

In accordance with the guidelines outlined by the Centers for Disease Control and Prevention (CDC), the Centers for Medicare and Medicaid Services (CMS) and the Pennsylvania Department of Health (DOH) concerning higher-risk populations, such as the elderly, we have enacted a number of precautionary measures. These include a no visitation policy, universal wearing of face masks, suspension of group activities and communal dining, screening of staff at the start of every shift, and conservation of supplies. We know this has been difficult. But we also know these actions are necessary to protect those who are most vulnerable.

Our residents have done remarkably well adjusting to the changes in their daily routines. Our halls are a bit quieter, but there is still a strong sense of community. Throughout this crisis, every team member has been working hard, not only to provide high-quality care, but to truly serve our residents by fostering friendship and compassion. Coordinating

FaceTime and Skype meetings, updating families, implementing creative activities, spending a little extra one-on-one time with residents – acting as caregiver, friend and stand-in family member, they are doing incredible work to bring our mission to life.

We are also grateful for the countless ways people have chosen to support us. For donations of hundreds of fabric face masks by local families, the Mount Carmel Quilters Guild, Mask-Erie, and the Hands All Around Quilt Guild. For numerous plastic face shields donated by The Plastek Group, Mercyhurst Prep Technology and Business Department, and the Erie County Gaming Revenue Authority. For the 288 flowers donated on Easter weekend to our residents by Larese Floral, Floral Affair, Foster's Rose of Sharon and Gary's Flower Shoppe. For the families who directed some or all of their stimulus check toward our needs. For the heartwarming cards. For the kind words. Big and small, these acts of generosity mean the world to us.

Over the past 135 years, we have proven our commitment to serving seniors and their families, time and time again. This year is no different. As we navigate the weeks ahead, we hope you can take comfort in knowing that, in good times and in bad, we're here for you and we're committed to doing what we do best – *loving to care*.

The Alzheimer's Association presents award of recognition to Saint Mary's Home of Erie

After a yearlong collaboration that began early in 2019 with the Alzheimer's Association, Greater Pennsylvania Chapter, Saint Mary's has successfully completed "Person-Centered Dementia Care: A Habilitation Therapy Training Curriculum."

The training for employees focused on Habilitation Therapy, which is designed to encourage independence, positive emotions and purpose among people living with Alzheimer's and related forms of dementia. Habilitation Therapy is not to be confused with "rehabilitation," which focuses on helping an individual re-learn the abilities they have lost—something that is not possible for someone with progressive memory loss. Habilitation was developed with this understanding and is meant to help an individual use their remaining abilities and skills for as long as possible by "meeting the person where they are" or "joining them in their reality."

Upon completion of the program, Saint Mary's Home of Erie was presented with a plaque of recognition. Both campuses have seen success as they have already observed a decrease in Days Away, Restricted or Transferred Rates (DART) and believe it to be associated with the safer environment created through this training for both employees and residents.

BENEFITS:

- Increase in positive emotional experiences

- Lessened need for medications, including antipsychotics
- Reduction of stress among caregivers



Excellence in Tech

Saint Mary's receives national award

Saint Mary's Home of Erie received a Silver Award in the Safety category of the 2019 McKnight's Excellence in Technology Awards. The Silver Award recognizes the ongoing efforts made by Saint Mary's to advance the electronic health records in our facilities. The advancements helped administer integrative progress notes and eDOCs, eCharting, electronic physician orders and a facility dashboard. Saint Mary's has seen an increase in staff efficiency.

McKnight's Long-Term Care News is a national media outlet that serves those in the long-term care field. The awards are given annually to skilled nursing and senior living providers who lead the way in utilizing new technologies to improve resident care. Other award recipients in the Safety category include Bethel Pointe in Muncie, IN, which won Gold, and Villa Healthcare in Skokie, IL, which won Bronze.

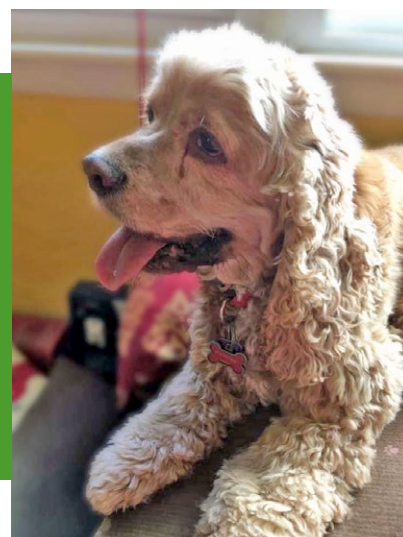


A "Shirley" Good Time

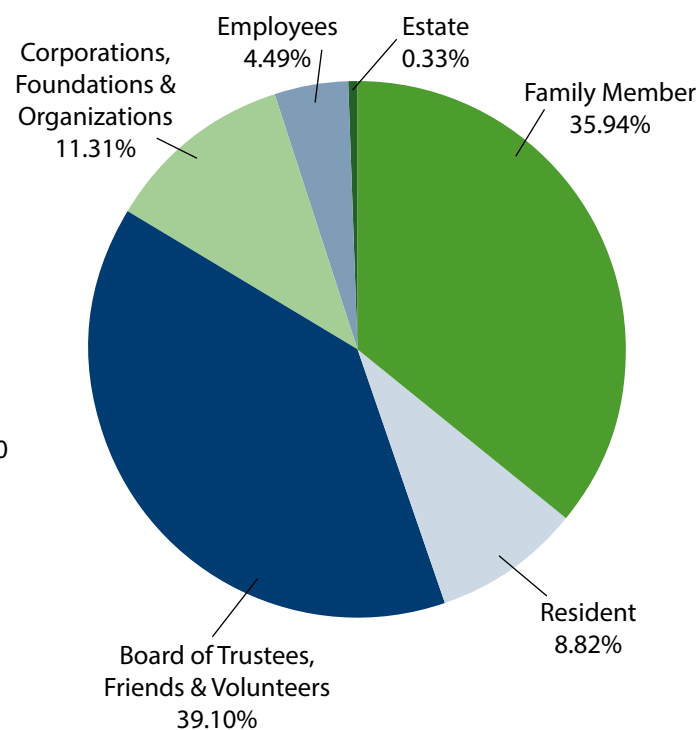

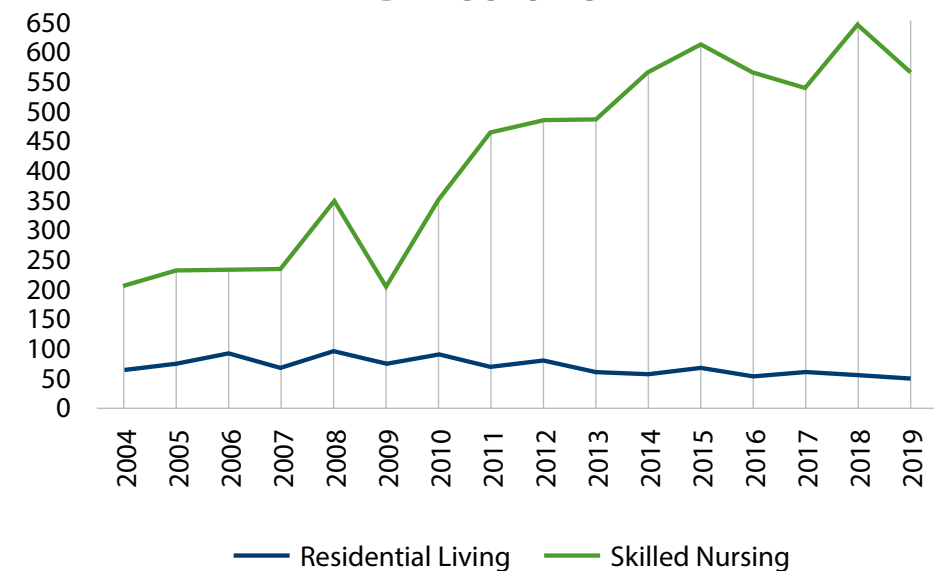
OPERATING EXPENSES
