### Phyllis McCracken, SSJ to Retire as President/CEO of Saint Mary's Home of Erie

It is with a fond farewell that the Board of Trustees announces the departure of Phyllis McCracken, SSJ as President/CEO of Saint Mary's Home of Erie effective June 30, 2019. Sister Phyllis leaves Saint Mary's after 35 years of service to assume an elected role of Leadership with the Sisters of St. Joseph of Northwestern Pennsylvania.\* Sister Phyllis has served as the President/CEO of Saint Mary's for the past 17 years. Allen L. Bonace, current Chief Operating Officer, will succeed Sister Phyllis as President/CEO of Saint Mary's Home of Erie, effective June 1, 2019.

Sister Phyllis joined the ministry of Saint Mary's Home of Erie in 1983 as the Assistant Director of Nursing. She has since held the role of Acting Director of Nursing, Vice President for Patient Care Services, Vice President for Special Projects and Vice President for Planning. In 2001, she was named President/CEO. Over the years, Sister Phyllis has been key to the success of many large-scale projects. She was instrumental in the establishment of the Gallagher Center, the first free-standing facility in Northwestern Pennsylvania for persons with Alzheimer's and Dementia. She expanded Saint Mary's services by planning, developing and overseeing the building of a

second campus, Saint Mary's at Asbury Ridge, and later of 26 Independent Living homes, the Carriage Homes at Asbury Ridge. Under her direction Saint Mary's was accredited as a Continuing Care Retirement Community (CCRC), offering seniors access to a full continuum of specialized services in one location to meet their changing needs as they aged. Sister Phyllis also had the foresight to understand the increased expectations of Retirement Communities in the future and as a result oversaw the \$21 million Replacement and Renovation Project at Saint Mary's East. She has served on the Boards of many local organizations, has spoken at numerous professional and educational events, and has always been a strong advocate in the community for senior healthcare. Recently on March 6, 2019, Sister Phyllis was one of 13 women honored with a "Women Making History" award from the Mercy Center for Women. This award celebrates women who are dedicated to helping others and who have made an impact in their community. The impact Sister Phyllis leaves on the Saint Mary's community is enduring. We cannot thank her enough for her many years of selfless leadership and passionate service.

"My ministry at Saint Mary's has been one of the highlights of my life. It has been a privilege to be entrusted to serve the Residents, their Families, Employees and Board both past and present," Sister Phyllis reflected. "I hope my presence has served to enhance our Mission and Vision. I have stood on the shoulders of giants and their legacy lives on. I am confident Allen will continue this legacy into the future."

Allen joined Saint Mary's Home of Erie in 2003 as the Director of Nursing at Saint Mary's at Asbury Ridge. In 2016, he was promoted to Vice President for Special Projects. Most recently, in January of 2019, he was appointed to the newly created position of Chief Operating Officer. Allen brings a track record of strong leadership and proven success to his new position as President/CEO. He has played a crucial role throughout his tenure in advancing the care provided by Saint Mary's Home of Erie. Major accomplishments include: oversaw the implementation of an Electronic Health Records Management System resulting in improved accuracy and order follow-through; established the Quality Assessment Performance Improvement (QAPI) plan; established an Infection Prevention and Antibiotic Stewardship Program reducing the spread of disease and limiting the unnecessary use of antibiotics; and successfully spearheaded the initiative to achieve a 5-year CARF-CCAC Accreditation, positioning Saint Mary's East and Saint Mary's at Asbury Ridge as two of only three CARF-CCAC Accredited Continuing Care Retirement Communities in Erie, PA.

"It is truly a pleasure to be part of an organization as exceptional as Saint Mary's is, with such a rich history of providing outstanding care," said Allen. "I am inspired by the Mission and works of the Sisters of St. Joseph and humbled by the confidence they have placed in me as the next leader of Saint Mary's Home of Erie. I am committed to leading with a steadfast focus on our Mission of 'Loving to Care.'"

Allen attended Ohio University, Athens, OH, and received an Associate Degree in Nursing from Hocking College,

Nelsonville, OH. In addition, he holds a dual Master of Science in Nursing and Master in Business Administration degree from Gannon University. Allen is board-certified as a Nurse Executive by the American Nurses Credentialing Center. He currently serves on the Board of Directors at Erie Homes for Children and Adults, Inc. (EHCA) and the Professional Advisory Committees for UPMC Home Care and Family Hospice and Mercyhurst University Nursing Department. He also holds a Pennsylvania Nursing Home Administrator's license. Prior to his time at Saint Mary's, Allen held staff and management positions at both Hamot Medical Center (now UPMC Hamot) and Saint Vincent Health Center (now Saint Vincent Hospital). He also served for 10 years as an Adjunct Faculty member in the graduate Nursing program at Villa Maria School of Nursing, Gannon University. In addition to being published in several leading journals, Allen is a member of the American Organization of Nurse Executives, the Pennsylvania Organization of Nurse Leaders and Sigma Theta Tau International Honor Society of Nursing.

"Sister Phyllis has been an exceedingly strong leader. Her hard work and dedication to Saint Mary's Mission of "Loving to Care" has always been genuine," stated Carol Mingarelle, Chairperson of the Board of Trustees for Saint Mary's Home of Erie. "She has consistently set goals to enhance the lives of our Residents while encouraging the development of new programs and services. Over the years, Allen has held numerous positions with a variety of responsibilities. His demonstrated management makes him well qualified to step into the role of President/ CEO." Carol continued, "The Board of Trustees sends their congratulations and best wishes to both Sister Phyllis and Allen as they begin their new leadership positions."


# New Appointments Made at Saint Mary's Home of Erie

# Advanced QAPI Accreditation

Saint Mary's East and Saint Mary's at Asbury Ridge each achieved Advanced Quality Assurance and Performance Improvement (QAPI) Accreditation in 2018. Saint Mary's East achieved Advanced Accreditation throughout all four quarters of 2018. Saint Mary's at Asbury Ridge achieved Basic Accreditation in the first and second quarters and Advanced Accreditation in the third and fourth quarters of 2018. Presented by Providigm, LLC, the Advanced QAPI Accreditation confirms that Saint Mary's is continually assessing items based on standards for excellence that affect Residents' quality of life and quality of care. Only 11 other nursing facilities in the state of Pennsylvania received Advanced QAPI Accreditation during the fourth quarter of 2018.





### **CARF-CCAC** Accreditation

In June of 2018, Saint Mary's East and Saint Mary's at Asbury Ridge were awarded a five-year term of CARF-CCAC Accreditation from CARF International. As an independent, nonprofit accrediting body, CARF's mission is to promote the quality, value and optimal outcomes of services through a consultative Accreditation process that centers on enhancing the lives of the persons served. An organization receiving accreditation has voluntarily put itself through a rigorous peer review process and demonstrated to a team of Surveyors during an on-site survey that it is committed to conforming to CARF-CCAC's Accreditation conditions and standards. This accreditation demonstrates that Saint Mary's is dedicated to its quest for quality programs and services.






